- (5) To be eligible for this Account You must have a Credit Union checking account with monthly; (i) direct deposit(s) of \$500.00; or (ii) at least ten transactions post to that account.
- (6) In order to earn dividends at the disclosed rate, during each calendar month You must have 10 or more specific transactions equal to or greater than \$1.00 post to Your Account. Such transactions must be ACH, Direct Deposit, Bill Pay, MasterCard Debit, share draft, or any combination thereof.
